1. Under National competitive bidding – Single Stage One Envelope procedures.

3. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following account of TUTH as specified below.

4. Pre-bid meeting will be held on 2083.03.19 (3<sup>th</sup> July, 2026). At 11:00 AM In TUTH General Administration Section Ka,.
5. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00, daytime, 2083.03.31 B.S. (15<sup>th</sup> July, 2026). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 PM 2083/03/31 at the office of TUTH, Maharajgunj. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs.2,80,000.00**, which shall be valid for 30 days beyond the validity period of the bid i.e. 2083/07/25 B.S. (11<sup>th</sup> Nov, 2026).
7. If the last date of purchasing and /or submission falls on a public holiday<sup>1</sup> applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the **bid and bid security** shall remain the same as specified for the original last date of bid submission.
8. Bidder must submit original Voucher of cost of bidding document and bid security guarantee or voucher during bid opening.
