1. The Tribhuvan University Teaching Hospital (TUTH), Maharajgunj invites Electronic bids from eligible bidders for Procurement of DR Portable Detector Panel- 1 set under National competitive bidding – Single Stage One Envelope procedures.
2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of TUTH or may visit PPMO egp system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
3. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following account of TUTH as specified below.
4. Pre-bid meeting will be held on 2083.05.08 (24<sup>th</sup> Aug, 2026). At 11:00 AM In TUTH General Administration Section Ka,.
5. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00, daytime, 2083.05.18 B.S. (3<sup>rd</sup> Sep, 2026). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 PM 2083/05/18 at the office of TUTH, Maharajgunj. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs.40,000.00**, which shall be valid for 30 days beyond the validity period of the bid i.e. 2083/09/16 B.S. (31<sup>th</sup> Dec., 2026).
7. If the last date of purchasing and /or submission falls on a public holiday<sup>1</sup> applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
8. Bidder must submit original bid security guarantee or voucher during bid opening.
